


BSL Safeguarding Strategy

Safeguarding at BSL...what does it mean?

At BSL, we care about keeping children and adults safe. We want everyone to feel protected and respected. We do not allow harm of any kind.

We follow the 11 Victorian Child Safe Standards and make safety part of everything we do.



What we have done so far (2022–2024)

In the last three years, BSL has made big steps to keep children and adults safe. Here is what we have done:

- Created a special role to lead safeguarding work
- Made a Safeguarding Policy to guide us
- Trained staff on safeguarding reporting, and family violence
- Set up a clear way to report safety concerns
- Improved how we hire and welcome new staff
- Checked safety risks in all our programs
- Chosen Child Safe Champions to help across BSL

Our Plan for 2025-2027

Over the next three years, we will keep building a strong safety culture

- **Safe People** -making sure our workforce know how to keep people safe
- **Safe Services** – making sure our services and online spaces are safe
