



# TERMS AND CONDITIONS

## Saver Plus Refer A Friend Promotion

**Promotion name:** Saver Plus Refer A Friend Draw

**Promoter:** Brotherhood of St. Laurence (ABN 24 603 467 024)

**Eligible Countries/ States/ Territories:** Australia, New South Wales, Queensland, Victoria, Western Australia, Tasmania, South Australia, Australian Capital Territory and Northern Territory

This is an ongoing promotion that commenced at 9:00am AEDT on 01 November 2024. From **1 April 2026**, the promotion will operate as a **monthly prize draw** and will continue until further notice.

**Eligible Entrants:** This promotion is open to current participants of the Saver Plus program and previous participants who have successfully completed the program who currently live within the Eligible States and Territories of Australia as listed above. This Promotion is eligible to individual persons only, businesses or corporate entities of any kind are not Eligible Entrants.

An Eligible Entrant must be at least 18 years old. Persons under the age of 18 are not permitted to enter and if a winner is discovered to be under the age of 18 (either at the time of entering or winning the draw) they will be automatically disqualified and are not an Eligible Entrant. In this instance a new winner will be drawn.

Directors, management and employees of the Promoter and any partners or delivery agencies for Saver Plus, their immediate family are not permitted to enter and are not Eligible Entrants. This means directors, management and employees of the Brotherhood of St Laurence, ANZ, The Smith Family or Berry Street are not eligible to participate.

Eligible Entrants can win a maximum of ONE (1) Coles gift voucher per calendar year.

### Monthly Prize Draws

From **1 April 2026**, one (1) Coles gift voucher valued at **\$250** will be given away **each month**.

### Bonus Promotional Period:

For the months of **May and June 2026**, one (1) Coles gift voucher valued at **\$500** will be given away **each month**.

### Total Prize Pool

The **maximum total prize value** for the **2026 calendar year** (from 1 April 2026 to 31 December 2026) is **\$2,750**.

The **maximum total prize value** for **each subsequent calendar year** is **\$3,000**, based on the award of **one (1) Coles gift voucher valued at \$250 per month**.

**Total number of Prizes:** From 1 April 2026 - Up to twelve (12) prizes nationally per calendar year.

### Definitions

**Referrer** – is the past participant of Saver Plus who tells their friends or family about Saver Plus.

**Referee** – is the person who finds out about Saver Plus from a past participant and is enquiring to join the program.

**Method of entry:** To enter a person must:

- (a) refer friends, family or colleagues to the Saver Plus program.
- (b) share their unique Saver Plus referral code with their friends or family. The unique code must be quoted by the referee (the person joining the program) and is used to enter the Referrer (the past participant of the program) into the draw.
- (c) if you are a past participant of Saver Plus and have forgotten your unique referral code, you may either contact your **Savings Coach** or email [saverplus@bsl.org.au](mailto:saverplus@bsl.org.au). Please include your full name and either your email address, residential address or mobile phone number so your code can be confirmed.
- (d) consent to sharing their name and phone number to their Referee in the knowledge that this information will be shared with the Saver Plus National Office team at the Brotherhood of St. Laurence. This information will be used to both conduct the draws and to contact the winners of the draws. This information will not be used for any other purpose.
- (e) If the Referee is eligible to join and successfully enrolls into the program, the referrer will receive **one (1) entry into the applicable prize draw**. If more than one referee enrolls into the program, the referrer can receive more than one entry. **For referrals made on or after 1 April 2026**, the Referrer will receive **one (1) entry into the monthly prize draw**, with the draw determined by the date the referee enrolls into the program.

**Maximum number of entries:** There is no maximum number of entries. The number of entries a Referrer can receive is based on how many of their Referees enrol into the program

**Prize draw details:**

The winner of the Prize will be determined by a random draw from all valid entries received during the applicable promotional period. **For entries received on or after 1 April 2026**, a prize draw will be conducted **monthly** from all valid entries received during the **previous calendar month**.

Draws will be held on the **second Tuesday of each month**, unless that day is a public holiday, in which case the draw will be conducted on the following business day.

**Notification of winners:** The winners will be notified in writing via text message and via phone call within three (3) business days of the draw. If the winner cannot be contacted within one (1) week, the prize will be re-drawn.

**Public announcement of winners:**

From 1 April 2026, the first name and state of residence of each winner will be published in the Winners section of these Terms and Conditions on the third Thursday of the month in which a prize draw has taken place.

**Claiming the Prize:** The Prizes must be claimed by responding to the email providing all details reasonably requested by the Promoter. If the prize is not collected within two (2) week, the prize will be re-drawn.

**Unclaimed Prizes:**

If a Prize has not been claimed in the manner and by the time specified above, or if the Promoter is unable to contact the winner after making reasonable attempts to do so, the Promoter may conduct a second draw to award the Prize.

From 1 April 2026, in the event of a second draw, the name of the winner(s) of the Prizes will be published in the Winners section of these Terms and Conditions no later than three (3) weeks after the second draw.

**Permit reference:** N/A as total prize pool is less than \$5,000.

**Collection of information:** The Promoter's privacy policy applies to the collection of entrants' personal information.

**Conditions of Entry**

These Terms and Conditions incorporate and must be read together with the details outlined in the Schedule above. By entering the Promotion, each entrant accepts and agrees to be bound by these Terms and Conditions. Where there is an inconsistency between the Schedule and the Conditions described below, the Schedule will prevail.

**Entering the Competition**

The Promoter reserves the right, at any time, to request verification of the age, identity, residential address, or any other information relevant to an entrant's participation in the Promotion. If a winner cannot provide suitable proof, the winner will forfeit the Prize in whole and no substitute will be provided.

2. The Promoter reserves the right to disqualify any entrant who provides false information, fails to provide information that is reasonably requested by the Promoter or fails to respond within a reasonable time to any reasonable request.

3. Any information entrants provide will be collected and used by the Promoter for the purpose of conducting this Promotion. If any information requested by the Promoter is not provided, the entrant may not participate in the Promotion. The Promoter may disclose entrants' personal information to its contractors and agents to assist in conducting this Promotion or communicating with entrants. The Promoter is bound by the National Privacy Principles in the Privacy Act 1988. Entrants can request access, update, or correct the personal information the Promoter holds about them by contacting the Promoter at the address stated above. The entrants' personal information will not be shared with any agencies who are not directly involved with the delivery of the Saver Plus program.

4. All entries considered not genuine, incomplete, inappropriate, or offensive by the Promoter for any reason will be disqualified.

### **Prizes**

1. Each Prize is not transferable, exchangeable, or redeemable for cash.

2. If a Prize is not available for reasons beyond the Promoter's control, the Promoter reserves the right to substitute the Prize with a prize of equal or greater monetary value.

3. The Prize must be taken as stated and no compensation will be payable if a winner is unable to use the Prize as stated.

### **General**

1. The Promoter accepts no responsibility for any costs incurred by Participants in entering the Promotion. Prize winners are advised that tax implications may arise from their Prize winnings, and they should seek independent financial advice prior to the acceptance of these terms and conditions.
